Starting from October 1, 2025, the issuance of border insurance contracts at the border crossing points for vehicles registered in foreign countries, entering the territory of the Republic of Azerbaijan, without presenting "Green Card" will be suspended. From that date onwards, border insurance contracts can only be concluded in advance – either through the www.tpl.az online platform or by applying to insurance companies operating in Azerbaijan.

The Embassy would appreciate the kind assistance of the esteemed Ministry in forwarding the above-mentioned information to the relevant government bodies of the Republic of Slovenia.
