*In Paint project will set up a Work Based Learning open platform to support VET Institutes and Painting Trade in Europe*

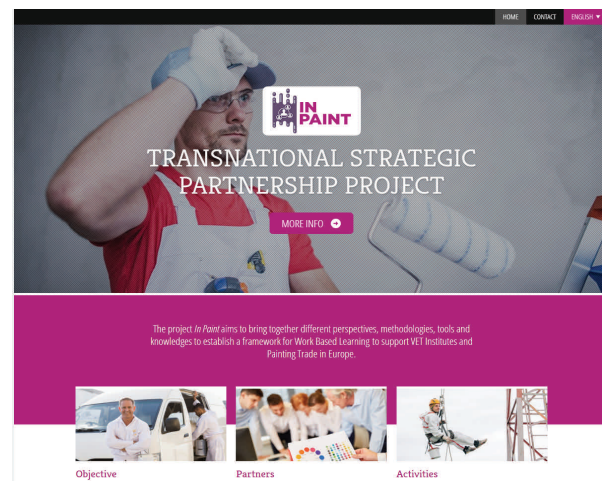

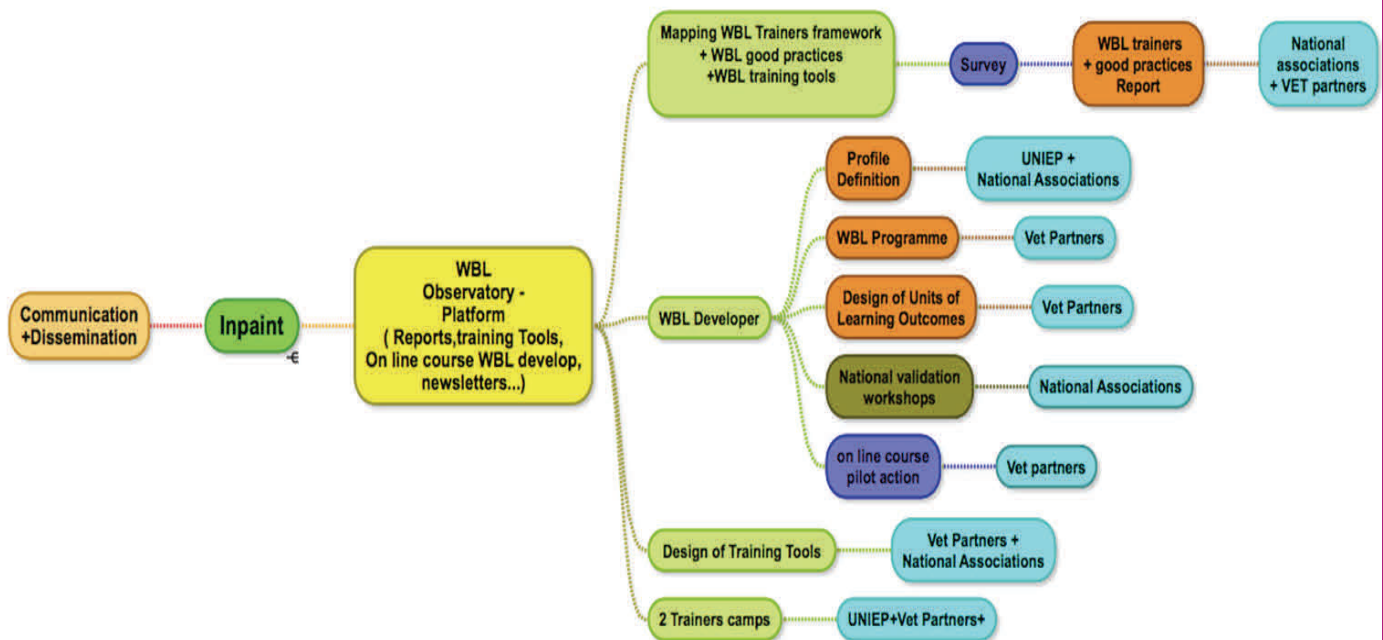


*In Paint Project has been officially launched on 20<sup>th</sup> October 2017 at the kick-off meeting performed in Bled (Slovenia).*

The project reached **6<sup>th</sup> month** now and the scheduled activities have been well implemented.

- The main tasks of the **WP2** concerning the designing of the Work Based Learning Observatory Platform have started. The Platform will be an open space gathering sector WBL data, news, videos, training tools, guidance to the companies and a WBL Developer online course. All data and information collected in the platform structure must be disseminated to a wide range of future users of the platform - VET providers, teachers/trainers, companies and learners. Different stakeholders have been interviewed about which type of information they expect or wish to find within this platform and their answers have already been collected. [PDA \(UK\)](#), leader of the WP2 has been doing the final report, that will follow soon. The output will be significant to better evaluate which information and data should appear in the final platform, following the requirements of the painting sector stakeholders.
- The **WP3**, led by [Landesinnung der Maler und Tapezierer Niederösterreich \(AU\)](#), is on the way too. It consists in mapping the situation of Work Based Learning. The starting point was to analyse the state of art in 6 countries in order to identify the situation of teachers and trainers within the WBL training, the good practices and the training tools. With reference to this objective, some questionnaires has been distributed among UNIEP partners' associations in order to compare the situation in the different countries. After that, a desk research will be carried out based on planned or existing WBL and apprenticeship reforms, and examples of best practices and policy frameworks.

# Dissemination



During the **Expert Meeting** organised each year by **the Chamber of Craft and Small Business of Slovenia**, the Secretary of the painting section, **Mr. Igor Pipan**, presented UNIEP' activities and In Paint project. The explanation of the reasons that stimulated the idea of the project and its main goals encouraged the interest of the meeting's participants and various painting contractors. Therefore, the Chamber of Craft and Small Business of Slovenia decided to plan more meetings with the painters' section in the future in order to inform the stakeholders about the main outputs of the project .

Within the edition of *November 2017* of the **FARBENKREIS Magazine**, the partner association **Landesinnung Der Maler Und Tapezierer Niederösterreich (AU)** presented In Paint project, its goals and activities. The main focus was on the summary of the kick-off meeting that took place in Bled (Slovenia) where all the partners met UNIEP for launching the project defining all the different steps to follow for the next two years.
